

## **Terms and conditions for HGC and DENS Bike Project competition**

1. This offer has been organised by Hemel Garden Communities (HGC), The Forum, Marlowes, Hemel Hempstead, Herts, HP1 1DN.
2. The competition is open to all residents of the UK, the Channel Islands and the Isle of Man aged 16 or over (unless otherwise stated) and will be known as the 'Entrant' and will run from **2pm Monday 9<sup>th</sup> June 2025 until 5pm Monday 14<sup>th</sup> July 2025**.
3. Registration to take part in the competition is only available by using the following method:
  - By completing the entry form.
  - Only one entry is allowed per person if you enter more than once your subsequent entries will not count.
  - No other method of entry will be accepted.
4. Subject to 3 above you will automatically be entered into the draw.
5. Subject to condition 3 employees of Dacorum Borough Council, St Albans District Council and Hertfordshire County Council and members of their families and household are also eligible to enter.
6. Registration will be open approximately 2pm Monday 9<sup>th</sup> June 2025 until 5pm Monday 14<sup>th</sup> July 2025.
7. The potential winners will be drawn at random from all completed entry forms. The prizes will be allocated as follows:
  - All entries will be entered into the grand prize draw to win one £100 voucher towards a bike service, repairs or a bike purchase from the DENS Bike Project. This is drawn at the end of the promotion (Monday 14<sup>th</sup> July 2025).
  - 5x £50 vouchers towards a bike service, repairs or a bike purchase from the DENS Bike Project will be given away in total. One £50 voucher a week from the 9<sup>th</sup> June until 14<sup>th</sup> July 2025.
  - 15 x £25 vouchers towards a bike service, repairs or a bike purchase from the DENS Bike Project will be given away in total. Three £25 vouchers a week from the 9<sup>th</sup> June until 14<sup>th</sup> July 2025.
8. The prizes will not be won if valid contact details are not provided and the process will continue until a winner is found.
9. HGC reserves the right to disqualify any entrant who did not meet the entry requirements or if it is incorrect.
10. HGC's decision as to entrants and winners is final and no correspondence relating to the competition will be entered.
11. The vouchers will be valid three months from the date of issue.
12. Entrants agree to take part in any post-competition publicity if required (date, time and location to be agreed). Winners under the age of 18 must be accompanied by an adult.
13. The full list of winners will be announced on the HGC [website](#) and Instagram account (@hemelgardencommunities from 5pm on 16<sup>th</sup> June 2025, with a full list of winners names appearing by Monday 14<sup>th</sup> July 2025. All winners will be notified by email within

3 weeks of the closing date of this competition. The prize must be accepted within 2 weeks of receiving the email, failure to accept the prize may lead to the prize being withdrawn.

The prize description may include additional requirements which alter the eligibility of that particular round of the competition, impose additional rules or restrictions specific to that prize.
